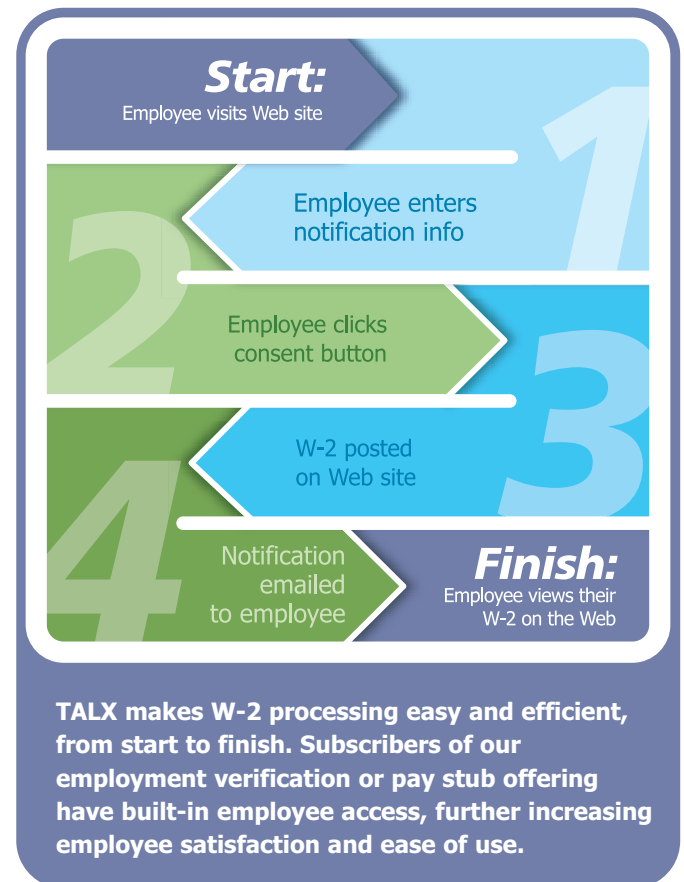

Improved convenience and efficiency start at the very beginning, when TALX creates electronic W-2s from data provided by the employer. This same data is also used for reissues and corrections. The system accommodates both current and former employees, and is in compliance with the IRS.

Information contained in these electronic files can be immediately delivered to consenting employees via the Web (or printed out and mailed First Class within days). Employees who consent to electronic delivery of their original W-2 have the benefit of being able to retrieve it from the Web sooner than the employees whose W-2 is being printed and mailed.

Relief from Reissue Requests

Because TALX empowers organizations with self-service, your current and former employees can request reprints at any time, from anywhere, without contacting your payroll department. Employees simply connect with our secure system via phone or Web, enter their User ID and PIN for verification, then make their request. Fulfillment of requests is highly flexible, designed to accommodate a variety of employee preferences. Our system delivers W-2 reissues by mail, fax, or the Web. Because the employee has the freedom to choose where their reissue is sent, the option to have it sent directly to a lender or tax preparer is in their hands.

Timesaving Correction Service

Yet another advantage of increasing employee control, this service collects requests for corrections (W-2c forms) through a secure Web site or the TALX call center. Once collected, employee correction requests are presented to authorized payroll staff in a clear, organized manner on your Web administration site. Authorized users then view and approve or deny requests electronically. The system takes care of the rest, issuing a W-2c or responding with a denial. Cover letters of explanation may be included for either outcome. Approved W-2cs immediately become part of the employee's complete W-2 record.

High-Level Security & Accuracy

As W-2 data is sensitive and subject to federal regulations, every precaution is taken to ensure both security and accuracy. TALX performs extensive testing and reviews before distribution. And we keep you informed throughout the process, allowing approved managers access to audits and error reports.

Our service also ensures against potentially disastrous loss of data with double archiving. A backup of each electronic W-2 file is stored on our secure system. As extra protection, we also create a CD-ROM archive of all current year W-2s and share it with you for safekeeping.

Online Reporting & Approvals

TALX makes it easy to manage administration related to W-2s through webManager. This user-friendly online tool is seamlessly integrated into all TALX services, and can only be accessed by authorized staff members with a valid User ID and PIN. A "control center" for W-2 issues, webManager can be used to:

- Create a W-2c
- Modify employee settings
- Perform transactions for employees
- Access reports

Designed to suit a variety of personal work styles, webManager allows the user to schedule automatic reports on service usage, minor correction requests, and more. Reports can be viewed online, printed out, or downloaded according to user preferences and needs. All reports are compatible with Microsoft Excel and Access so they can easily be shared with others.
